The system shall be installed in strict accordance with the applicable Tamlyn® installation instructions in a properly constructed and designed wall system, following the applicable building codes and accepted industry standards for each type of structure. 15 YEAR PRODUCT ONLY LIMITED WARRANTY

Tamlyn® warrants that Products covered conform to the appropriate Acceptance Criteria when installed in strict accordance with the applicable Tamlyn® installation instructions for use. If the Product contains a manufactured defect identified and covered by this warranty, Tamlyn®, at its sole discretion, will either, (a) replace the Product in question, (b) provide a replacement Product of equal quality or value as a substitute, or (c) refund the original purchase price of the Tamlyn® Product. In no event shall Tamlyn® be obligated to pay in excess of the original purchase price or for the cost of labor for such repair or replacement.

25 YEAR PRODUCT AND LABOR LIMITED WARRANTY

Subject to the following specific terms and conditions, the Products(s) covered, when installed as a system with Tamlyn® required accessory Products, on a properly registered project are warranted for a period of twenty-five (25) years from the date of purchase.

Tamlyn® Product(s) must be installed in strict accordance with the applicable Tamlyn® installation instructions for use, in a properly constructed and designed wall system, following the applicable building codes and accepted industry standards for each type of structure. Tamlyn® warrants that the Product(s) covered will meet applicable water drainage and holdout per ICC-ES-AC38 test standards. To qualify for this Product and Labor Warranty, you must exclusively use Tamlyn® Products to the extent applicable on each type of construction. When all conditions under this Product and Labor Limited Warranty are met, if damage to the building is caused solely by the failure of a warranted Product(s) to meet the applicable physical property, then Tamlyn® will provide replacement Product for the area affected and pay reasonable or customary construction repair costs to correct a problem that arises solely out of the failure of the Tamlyn® covered Product(s) to meet the required characteristics. Tamlyn® will not have any liability, expressed or implied under this warranty, for the labor cost of repair beyond the actual area of damage and not to exceed \$20,000 per building structure.

Tamlyn® makes no additional warranties except such as set forth herein. The remedies provided in the limited warranties are the sole and exclusive remedies for any breach of warranty. If any Products are repaired or replaced under this warranty, ongoing warranty coverage will continue from the start date of the original warranty and not from the date of repair or replacement. This warranty is not a performance claim and no other warranties are made by Tamlyn® expressed or implied. Tamlyn® shall not be liable in tort or any contract or otherwise for any direct, incidental, consequential, punitive or any other damages including but not limited to damage of

property, loss of profits, loss of use, lost revenue, personal injury or death. Tamlyn's complete liability and the exclusive remedy are limited to repair, replacement or refund on the basis stated herein.

WHAT IS NOT COVERED BY THESE WARRANTIES

None of the warranties set forth herein cover

- The negligence or willful misconduct of the Builder, General Contractor or Professional Installer or of any third party, including the building owner
- 2. Acts of God, including but not limited to fire, lightning, hurricane or high winds
- 3. Defects in the structure or a component of the structure (e.g., window, door, or wall system), contamination from building materials, nonstandard use or application of the Product(s)
- 4. Vandalism, harm caused by another, foreign objects, modifications or agents, including the use of materials incompatible with Tamlyn® Products
- Any representation, condition or promise made by an outside or third party on behalf of Tamlyn® with respect to such Products
- Improper installation of the Products, non-standard use, improper building practices or design not in accordance with the applicable building code or industry standards, any deviation from approved construction plans or project specifications

HOW TO FILE A CLAIM

- III. Provide Tamlyn® with an opportunity to inspect the project and collect samples of installed Product(s) subject to the warranty claim within sixty (60)days after Tamlyn® receives notice of your potential claim
- IV. Provide Tamlyn® representative access to recover samples of any associated Product(s) from the project in sufficient quantities to perform testing and determine cause of failure whether or not the Product(s) failed due to causes as
